## TECHNOLOGY DEVICE USAGE FEE AGREEMENT

(HIGH SCHOOLS)

This is an agreement between the **Dakota Ridge High School**, by and through **Jefferson County School District R-1**, its Student (*name of student*) \_\_\_\_\_ and, if the Student is under the age of 18, the Student's parents or guardians ("Parents").

**The Device:** Lenovo N42 , **with** power cord.

**TOTAL COST \$ 219.00**

The High School providing and assigning the Device described above to the Student for the Student's exclusive and educational use. With the Device, the High School is also providing access to the internet and to High School and District systems, software, and files. The High School is also providing technological support and security for the Device.

While the Student uses the Device, it remains the property of the High School.

The Student will pay a usage fee in the amount of \$ 219.00 before or at the time when the Student takes possession of the Device.

While the Student is in possession of the Device, the Student will:

1. Take good care of the Device and protect it against damage and loss.
2. Keep the Device and all access information and passwords relating to the Device under control.
3. Not allow others to use the Device.
4. Use the Device in accordance and compliance with all of the School's use instructions, policies, and requirements concerning the use of School and District property, electronic systems and files, and access to and use of the internet, all of which are incorporated herein as they are in effect on the date when the last of the parties has signed this agreement and as the District may change them from time to time.
5. Use the Device only for academic, educational, and school-related purposes.
6. Inform the School as soon as the Student or the Parents become aware that the Device is damaged, destroyed, lost, or stolen. Obtain a replacement from the School. The School may charge for any damage or loss up to but no more than greater of: (1) the Total Cost of the Device stated above, or (2) the cost of replacing the Device.
7. If the Device is lost or stolen, cooperate with the School to stop unauthorized access to the Device and to data or information on, or accessible through, the Device.

When the Student graduates from the High School, or if and when the Student leaves the High School earlier than graduation, the Student, Parents, and the High School may agree for the Student to keep and obtain ownership of the Device. If so, the High School will then, at that time, ask that the Student enter into a contract to transfer ownership of the Device from the High School to the District. The Student will then be responsible for obtaining their own internet access, for keeping software and apps updated, for maintaining IT security, and for lawfully recycling or disposing of the Device when it has reached the end of its useful life.

If the Student decides not to keep the Device, the Student shall return the Device to the High School no later than two days before the Student's last day at the High School. The High School is not obligated to pay a refund. However, the High School may decide to refund a portion of the fee if the Student has possessed the Device for less than 3 months and returns the Device undamaged, clean, and in working order.

This agreement expires when any one of these events occur, whichever occurs earlier: (1) when the Student has returned the Device to the High School and has paid all fees and costs that are due and payable under this agreement (such as usage fees and cost for damage to or loss of the Device, if any), or (2) the Student has signed a transfer of ownership contract with the High School.
